## CONDITIONS OF MEMBERSHIP

**The following information is for the advice of all prospective members. This information contains details of the obligations and requirements accepted by all members with regard to the payment of annual subscriptions, renewal of and resignation from membership and the penalties, which may result from failure to follow the guidelines. No membership application will be processed unless the signature of the applicant appears at the bottom of this page to acknowledge that they have read and fully understand these terms and conditions.**

### **Membership application**

I understand that if accepted for Membership, I will abide by the Constitution, rules, by laws and regulations of the North West Bay Golf Club Inc., and will be held accountable for all monies owing to the Club, relating to my subscription, from the date of acceptance, and any costs incurred by the Club in recovering any outstanding subscriptions or other costs in line with my obligations under the constitution until such time as I tender my **written** resignation.

I understand that, notwithstanding any other information I may receive, my application for membership or the change of category of membership is not approved until passed at a Committee Meeting of the Club. Under normal circumstances, the application would be presented to the next Committee Meeting after receipt of the application. Committee Meetings are held every month.

I understand that when this form, duly completed, is received by the Club along with the Nomination Fee which applies to the category for which membership is sought, I may play without payment of green fees and may play in competition to enable me to return five cards for handicap purposes. I understand that, should this application be refused, the nomination fee will be refunded in full.

Upon a nomination being approved by the Committee the Secretary Manager shall, with as little delay as possible, notify the nominee, in writing that the nomination for membership has been approved, the sum payable by way of subscription and the date by which it is to be paid and enter the persons name in the register of members

If a person who has been notified as above and fails to pay the annual subscription in full by the date referred to in the notification the Committee may revoke the approval of the nomination.

Once accepted into a specific category of membership, the Member, except at the written direction of the Committee, shall remain in that category for that playing year and shall be liable for the full subscription for that category.

### **Membership Renewal**

At the start of each playing year every Member shall be automatically accepted into the same membership category held immediately before that playing year and, except at the written direction of the Committee, shall remain in that category for that playing year and shall be liable for the full subscription relative to that category unless;

- 1 The Member has resigned in **writing**. Such resignation to be received by the Club before the expiration of one month after the start of the playing year.
- 2 The Member has applied, in **writing**, to the Committee for a transfer to another playing category and the application has been approved. Such application to be received by the Club before the expiration of one month after the start of the playing year.
- 3 If a sub junior, junior or intermediate member has, due to age changed category during the previous playing year they shall automatically be changed to their new category at the start of the current playing year and remain in this category for the whole year.
- 4 For the purposes of these rules, if a Member utilises their membership after the start of the playing year, they shall be taken to have renewed their membership in accordance with these rules and become liable to pay their full subscription accordingly.

## **Resignation**

A Member of the Club may, at any time, resign from the Club by delivering or sending by post to the Secretary Manager a **written** notice of resignation.

If a Member who has not utilised their membership since the start of any playing year resigns, after the expiration of one month but before the expiration of three months from the start of the playing year, they shall be liable to pay the Club the current subscription amount for the category in which they were a member immediately before the start of that playing year.

If a Member fails to resign from, or renew, the membership as set out in these rules within three months after the start of the playing year, they shall be removed from the membership register and shall be liable to pay the Club the current subscription amount for the category in which they were a member immediately before the start of that playing year.

For the purposes of these rules, if a Member utilises their membership after the start of a playing year, they shall be taken to have renewed their membership in accordance with these rules and, except at the written direction of the Committee, become liable to pay their subscription accordingly.

Upon receipt of the notice of resignation the Secretary Manager shall remove the name of the member from the register and the member shall cease to be a member of the Club.
